Assumption of Risk

I acknowledge that I have voluntarily applied to participate in a **Safari Race Series** event, which are made up of four, one-day bike races spanning from 20km to 120km in locations such as Tatu City, Iten, Naivasha and Vipingo Ridge, including associated events such as spectatorship, attendance and other activities during the races ("**Cycling Activities**"), organized by Savage Wilderness Safaris, the AMANI Project Ltd., its agents, associates, and affiliated organizations ("**Organizers**") and sponsored exclusively by NCBA Bank Kenya Limited PLC, LOOP DFS Limited and their affiliated organizations ("**Sponsors**"). I have read the description of the Cycling Activities so far as they appear on the website or in the literature supplied relating to the events.

I confirm that I have also listened to the safety briefings and I am aware that the Cycling Activities, whether in developed or remote areas, contains some inherent element of risk of illness, injury or death, which may be caused by involves many risks, dangers and hazards including, but not limited to: changing weather conditions; mechanical failure of bicycles; loss of balance; falls; difficulty or inability to control one's speed and direction; high speed descents; rapid or uncontrolled acceleration on hills and inclines; extreme variation or changes in the cycling surface including steep or slippery surfaces, railway tracks, potholes, curbs, trees, roots, tree stumps, logs, cliffs, rocks, rock drops, loose gravel, holes, depressions, etc.; streams and creeks, constructed features such as bridges, ramps, ladders, bumps, berms, jumps and drops; impact or collision with natural and constructed objects, pedestrians, motor vehicles or other cyclists; encounters with domestic or wild animals, failing to cycle safely or within one's own ability, strenuous physical exertion, physical contact with other participants while cycling including negligence on the part of other participants;

I recognize that such risks may be present at any time before, during, and after the Cycling Activities that I am participating in under the arrangement of the Organizers and Sponsors.

I am also aware that medical facilities may not be readily available or accessible during some or all of the time in which I am participating in the Cycling Activities, and, in order to partake in the enjoyment and excitement of the Cycling Activities, I am willing to accept the risks and uncertainty as being an integral part of the Cycling Activities. I hereby accept any and all risks of illness, injury, or death and assume full personal responsibility. I also assume the responsibility to purchase the necessary medical insurance to participate in the Cycling Activities.

Safety

I have been advised to wear protective clothing and gear to partake in the Cycling Activities and to comply with all applicable municipal and provincial highway laws and regulations.

Image Release

I further agree that the Organizers and Sponsors shall have the right to record, broadcast and otherwise exploit in any and all media throughout the world my activity and/or performance in the Cycling Activities and to use my name, image, likeness, voice and biographical information in connection therewith.

Release

In consideration of being permitted by Safari Race Series to participate in the Cycling Activities, I hereby agree that I, my heirs, executors or administrators, or any other member of my family, will not make a claim against the Organizers and/or Sponsors, their agents, associates, sponsors and affiliated organizations, officers, employees,

I am aware that this agreement is a release of liability and is a contract between me and the Safari Race Series, and I fully believe that the conditions stated and implied are reasonable, and sign it of my own free will.

I agree to hold harmless and indemnify the Organizers and/or Sponsors from and against any present or future claims, cause of action, loss or liability for injury to person or property, which I may suffer or for which I may be liable to any other person, related to my attendance or presence during the Cycling Activities.

Release on Behalf of Minors

I hereby certify that I am the adult parent or guardian of a minor child under the age of eighteen (18) years, and I am agreeing to take full responsibility for his/her safety and supervision while participating and/or attending the Cycling Activities.

I agree to hold harmless and indemnify the Organizers and/or Sponsors from and against any present or future claims, cause of action, loss or liability for injury to person or property, which said minor child may suffer or for which said minor child may be liable to any other person, related to said minor child's attendance or presence during the Cycling Activities.

I understand and acknowledge that I am fully aware of and assume the risks of managing a child during the Cycling Activities (including but not limited to the risk of serious bodily injury, trauma, illness, loss, unwanted contact, harassment, disability, death, and property loss or damage). I further understand that neither the Organizers nor Sponsors shall have responsibility to pay for medical treatment and related costs if said minor child is injured during the Cycling Activities.
